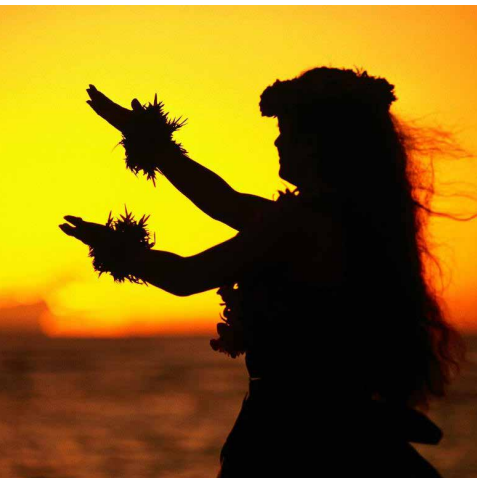

KAHULUI, MAUI

Maui is the boom island. Its blessed climate, varied landscapes, imaginative resorts, and sporting opportunities have made it Hawaii's top attraction. The carefree attitude of Maui is immediately evident in the charming city of Kahului. During your visit to Maui you might visit the Hauola Stone, which ancient Hawaiians believed had calming and healing powers, or enjoy the hospitality of an authentic Hawaiian luau. Maybe play a round of golf or ride to the top of the Haleakala Crater to catch some spectacular scenery.

HILO, HAWAII

Hilo is the capital of the "Big Island" and one of the state's rainiest cities making it incredibly green and colorful. Maybe tour the Japanese-style Liloikalani Gardens to see pagodas

and stone bridges, ride along the 11-mile Crater Rim Drive to study the sulfur banks and lava tubes of Volcanoes National Park or visit the Mauna Loa Macadamia Nut Factory.

KAILUA, KONA, HAWAII

This was once the seat of power from which the great King Kamehameha ruled his island empire. Located on the picturesque Kona Coast, Kailua Kona is close to the marine sanctuary of Kealahou Bay. This snorkeling haven is also home to the Captain Cook Monument.

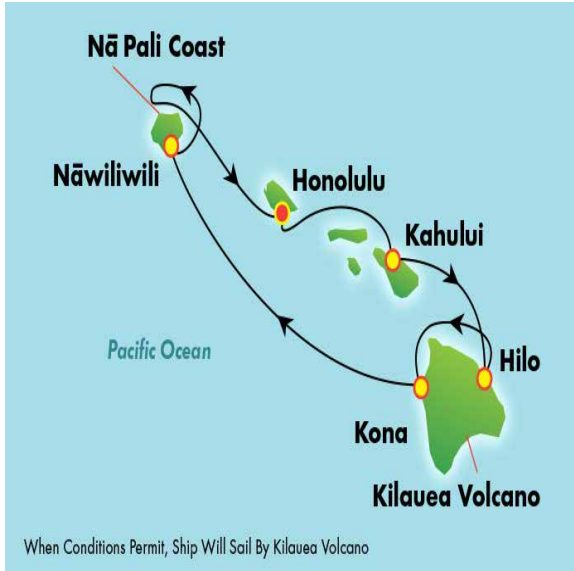
NAWILIWILI, KAUAI

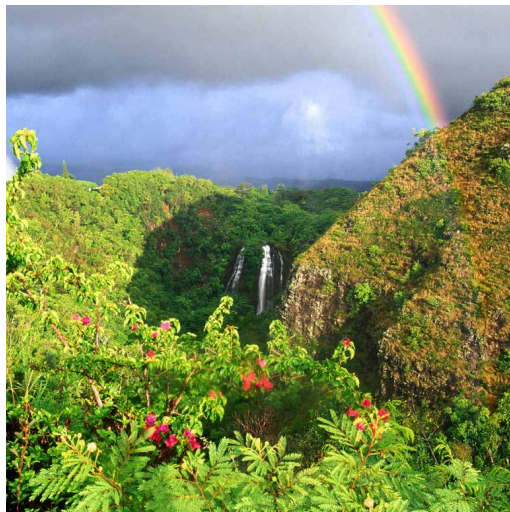
